# Broxton & District Parish Council 2012/13 ANNUAL REPORT



## Chairman's Report

Once again, it's my pleasure to bring you up to date with what Broxton & District Parish Council has been involved in on your behalf during the last twelve months.

This year much of our work has involved assessing how the preparation of a Neighbourhood Plan might help in tackling the issues and challenges raised by the Localism Act.

The Localism Act is essentially strongly in favour of supporting all development in both urban and rural areas unless there is an overriding planning reason not to authorise any such development. This is of great concern to people in rural communities as a massive influx of residents would strain the already stretched local services.

We cannot stop development, but with a Neighbourhood Plan we could shape the way we would like to see our villages grow. Achieving a balance between some growth and the managed provision of some affordable homes without spoiling the natural environment is a considerable challenge.

Against this background, the Parish Meeting, held in July 2012, was called to give local residents a brief outline of our area's Core Strategy regarding Neighbourhood Planning. This was presented by Councillor Mike Jones, our ward councillor and Leader of Cheshire West and Chester Council (CWAC).

CWAC is suggesting some 1050 houses per year in its Core Strategy. This Core Strategy is an over-arching plan, which allows for 5-10% growth in the community - the details of which will sit in Neighbourhood Plans. The Core Strategy will not be finalised until 2014. Unlike surrounding villages, to date, Broxton parish is not under immediate pressure from developers so we can afford to take a measured approach to the preparation of a Neighbourhood Plan.

This background briefing was followed by a thought-provoking question/answer session, and then an interactive session in which residents were invited to use maps and 'post-its' focusing on

- What do you like about living in the parish?
- Could any of these factors be improved?
- Is there anything the parish lacks or that you dislike?
- How would you like to see the parish develop over the next 10 years?
- What benefits to the community would you like to see from any developments?

The meeting concluded that it would like to see a Neighbourhood Plan developed and a number of volunteers came forward to assist the Parish Council in this task.

Following the July meeting which gave the mandate to go ahead, the Parish Council has

- Created a Neighbourhood Development Plan Working Group (NDPWG) under the auspices of the Parish Council. The group consists of a mix of Parish Councillors and volunteers, altogether about 10 people.
- Commented on the Cheshire West and Chester Council's Local Plan Preferred Policy Directions Consultation document
- Created drafts of several required documents. These will be circulated to the community for comment before inclusion in a draft Neighbourhood Plan

Community profile

Physical appraisal of the community

Vision for the future

Devised a Roadmap for the process

- Registered with CWAC in order to have access to expert planning guidance
- Registered with CWAC to enable them to undertake a sustainability report for the parish

The NDPWG has worked closely with adjacent parish councils and in particular with the larger Tattenhall and No Man's Heath parishes to learn from their experiences.

The next stage will be to seek further views and ideas from you about the scale and type of development you want at the Parish meeting to be held in **Brown Knowl chapel at 7.30 pm on Monday 20th May**. The output from this consultation will then be compiled with existing feedback information to form part of a survey form to be distributed to all households in the parish for comment. The survey results will be collected/reviewed at a social event – open to all residents - in June.
